Counsel for both parties will be given 3 minutes uninterrupted at the start of their argument before being stopped for questions from the court. Counsel should be present and be prepared to begin whenever their case is called.

Guests and visitors are required to pass through screening to enter the courtroom and are not permitted to enter with bags larger than 4.5 x 6.5 x 3 inches.

Security at the Judicial Center: All attorneys, guests, and visitors are required to pass through security screening to enter the Judicial Center.
