Attorneys in all cases scheduled for oral argument must check in with the Marshal in the courtroom to which the case is assigned (Capitol or Judicial Center), or virtual, if applicable, no later than **8:40 a.m.** Counsel for appellants should inform the Marshal of how much time they would like to reserve for rebuttal. Counsel for both parties will be given 3 minutes uninterrupted at the start of their argument before being stopped for questions from the court. Counsel should be present and be prepared to begin whenever their case is called.

Security at the Capitol: Attorneys who have appeared in the case and are not themselves a party are permitted to bypass screening and bring a bag into the courtroom. Other counsel will be required to show Security a photo ID along with proof of their affiliation with the law firm or agency representing the party at oral argument prior to bypassing screening and bringing a bag in. Guests and visitors are required to pass through screening to enter the courtroom and are not permitted to enter with bags larger than 4.5 x 6.5 x 3 inches.

Security at the Judicial Center: All attorneys, guests, and visitors are required to pass through security screening to enter the Judicial Center.
